

### SAINT TERESA OF JESUS (1515-1582) October 15

Let nothing disturb you; let nothing frighten you. Gifted with a passionate spirit, young Teresa dreamed of converting Muslims and becoming a martyr. All things are passing; God never changes. But her mother's death when Teresa was fourteen inspired lifelong devotion to Our Lady, and Teresa entered the Carmelites, Mary's order, despite her father's objections and her own fragile health. Patience gains everything. Initially, she enjoyed her lax convent's sociability and "busyness," but mystical prayer and John of the Cross's collaboration inspired her to reform the Carmelites. Whoever has God, lacks nothing. When her ideals encountered resistance and brought suffering, she maintained her peace----and humor. Discovered devouring leftovers, she told her mildly scandalized nuns, "When I fast, I fast! When I eat, I eat!" To nuns demanding less work and more praver in the convent schedule. she retorted: "What we really need around here are fewer starry eyes and more strong arms!" God alone is enough! The italicized sentences here are her "Breviary Bookmark," the simple, profound prayer of Teresa, the first woman Doctor of the Church.





OUR LADY OF THE MOUNTAINS CATHOLIC CHURCH PHASE 2: Changes to current parish safety protocols for next phase reopening.

COMMUNICATION WITH PARISHONERS: Once our protocols are approved we will communicate the changes with our parishioners via on-line parish website, school website, social media, radio, emails, and pulpit announcements.

ANY PARISHIONERS, CLERGY, STAFF, MINISTERS, OR VOLUNTEERS WHO ARE FEELING SICK IN ANY WAY MAY NOT COME ONTO PARISH PROPERTY.

THE CONTINUING USE OF TECHNOLOGY: Our parish will continue to collaborate with our neighboring parish, St. Andrew's Catholic Church, in providing live stream daily/weekend Masses. This will allow us to continue to serve our faithful Catholics who are unable to be physically present. Also, we will continue to provide opportunities for vulnerable parishioners to receive Holy Communion immediately after each weekend Mass. Additionally, we will continue to minister to the elderly who are more frail by taking Holy Communion to them in their cars in the parking lot. We will also offer Holy Communion by appointment to accommodate all contingencies.

TAKING HOLY COMMUNION SAFELY TO SHUT-INS: We will provide this ministry on a case-by-case basis only to those not thought/known to have Covid-19. The guidelines listed below for permanent deacons in ministry should be applied to Lay Ministers of Holy Communion. This will prevent us from any accidental transmission of the virus. Whenever possible, outdoor visits will be preferred to entering homes.

CONCERNING HOSPITAL CALLS: Clergy will continue to follow all local hospital protocols as they pertain to pastoral visits.

THE EARLIEST THAT PROTOCOLS MIGHT BE ADAPTED IS OCTOBER 3, 2020: Before implementing any new protocols we will make any necessary changes to our parish safety protocols as directed by our Bishop or his representative.

THERE IS NO GUARANTEE THAT WE WILL NOT HAVE TO REGRESS AGAIN: Parishioners will be reminded that we will continue to follow the advice from the CDC, (Centers For Disease Control), as well as State and County health departments. The faithful will be advised on the lingering potential risks of resuming any public activity, to include religious practice. IT IS CRUCIAL TO AVOID GIVING THE FALSE IMPRESSION THAT THE RISK AT THIS STAGE IS MARGINAL.

THE GOAL OF UNITY OF PARISHES AT TIMES MAY HAVE TO BE ADJUSTED TO REGIONAL NEEDS: Population centers, deaneries, or individual parishes might be placed on a different protocol in accord with local need.

THE USE OF FACE MASKS FOR ALL THOSE AGE 6 AND OLDER IS MANDATORY: Our resident and visiting clergy will set good example and use the mask before/after Mass, especially if greeting parishioners(while observing social distance). Clergy will not shake hands or make any other physical contact with parishioners during this phase. We will continue to emphasis the importance of social distancing. Anyone with a legitimate medical reason not able to use a mask is to clarify this matter with the pastor prior to attending public liturgy. Depending on the size of the parish church, those persons without a mask might be asked to be seated in a more distanced space from the majority. Pastors/clergy will explain to

parishioners the critical use of masks for the protection of all attending church. It is essential in protecting the most vulnerable among us as well as it is unquestionably consistent with the Church's pro-life teachings.

THE DISPENSATION FROM SUNDAY MASS OBLIGATION REMAINS IN PLACE AT THIS TIME: This applies to all Catholics living in or visiting the Diocese of Tucson. Please note that those identified by the CDC as more at risk, especially those with chronic health conditions or those over the age of 65, are encouraged to refrain from in-person events at Church. We will ensure all parishioners are aware that this is still in effect. We will ensure all have access to receive Holy Communion.

DAILY MASS MAY RESUME: Per the diocesan protocols we will follow the guidelines given for weekend Masses. We will sanitize per diocesan guidelines after each Mass. Pastors may use a gradual approach to reopening daily Mass. Only larger church buildings with proper ventilation or outdoor spaces may be used at this time. Next week air purification systems will be added our AC units to assist with purification and ventilation. I ran this improvement by Mr. John Shaheen which he approved. SMALL CHAPELS MAY NOT BE USED FOR ANY PURPOSE.

THE DISTRIBUTION OF HOLY COMMUNION WILL TAKE PLACE AT ITS NORMAL PLACE IN THE CELEBRATION OF THE MASS: Priests with compromised health may not give out Holy Communion personally. As several priests in quarantine have discovered, when a priest becomes sick or must quarantine because of potential exposure, the loss of his ministry can effectively suspend Sacramental ministry for his entire parish. For this reason we will follow the Bishop's request that all priests, including those who are healthy, not distribute Holy Communion at Mass personally and that Eucharistic Ministers of Holy Communion not in the CDC-listed categories of risk assume this liturgical ministry.

THOSE WHO DISTRIBUTE HOLY COMMUNION: Must will be masked and make generous use of handsanitizer. For the immediate future Holy Communion may only be given in the hand(this could change with the next phase of lessening our protocols). Parishioners will remain in their places at Mass and Eucharistic Ministers will bring Communion to them. This will prevent the breakdown of social distancing.

HOLY WATER WILL NOT BE PLACED IN FONTS FOR PUBLIC USE: We will bless the water parishioners bring to us in a container so that the faithful who request it for use in their homes.

PARISH BULLETINS: If we begin to distribute bulletins in Church we will have them available ONLY for self-pickup upon LEAVING the Church after Mass. Bulletins will be stored away between Masses. We will, for now, only continue to send the bulletin electronically.

COLLECTION BASKETS: We will not pass them from hand to hand. We will continue to utilize stationary dropboxes. They will be removed promptly after Mass. This is in compliance with **our** "**no touch**" **method** of taking the collection at Mass. We will continue to promote and encourage on-line donations.

DEACONS: Our deacons, liturgical ministers and volunteers under the age of 65, in good health and without chronic health issues may resume ministry while observing all standard protocols. Those over the age of 65 and with no chronic health issues may resume ministry at their discretion and in consultation with the pastor. Deacons, liturgical ministers and volunteers over the age of 65 with chronic health issues must refrain from public ministry. To return to public ministry deacons must seek permission from the Bishop and outline those ministries they wish to resume. The recommendation of the pastor is also required. Depending on the circumstances a letter from their medical doctor may be required.

THE SACRAMENT OF PENANCE: We may celebrate confessions indoors but not in a small/confined space like a confessional. A room larger than a confessional will be used if the penitent and confessor can observe social distancing protocols. Masks will be used by both and efforts for good ventilation will be employed. For now, will have confessions outdoors while employing mask and social distancing protocols.

MAXIMUM SEATING FOR INDIVIDUAL CHURCHES: We consulted with Mr. John Shaheen so as not to exceed one-third of pew space and to ensure that proper social distancing is observed between persons not living in the same household. Ushers will continue to have access to our large sign that indicates that Church is at maximum capacity. There will be no social gatherings before or after Mass or any other celebrations. I consulted with Mr. John Shaheen on our seating plan to ensure proper social distancing and he said it was in compliance.

CLEANING MEASURES: We will continue to employ aggressive cleaning measures/proper ventilation per our parish safety protocols. Per the cleaning/sanitizing guidelines established by the previous Pastor for phase 1, the church will be cleaned/sanitized before each Mass. Chairs (upholstered) will be sprayed and hard surfaces sanitized. We will continue to clean door handles, light switches, microphones and all other frequently touched surfaces. Restrooms are part of his sanitizing routine. Our drinking fountains are marked as off limits. We have designated people who perform this duty. Should they not be available, I have been trained by them on the proper procedures.

CONTINGENCY PLANS FOR INCREASED MASS ATTENDANCE: Should people quickly return to Mass in large numbers and seating limitations become problematic, per Diocesan protocols, we will add Masses on Fridays and/or Mondays. We understand that we have permission from our Bishop to use the Sunday scripture readings and Mass prayers for these additional days.

SINGING: One or two cantors observing social distancing from each other and the congregation is acceptable. Choir/congregational singing remains prohibited. We will not use hymnals/missalettes. Mariachi bands are not allowed to play in church. They are allowed to play outside except for trumpets. This is to avoid placing considerable contagion in the air. Social distancing must be employed. We will continue to follow these guidelines.

FUNERALS/WEDDING: We will follow ALL protocols for Sunday Mass while keeping careful watch so as to not exceed the maximum seating capacity.

BAPTISMS: Limit is 20 people. We will emphasize the critical nature of social distancing, which can break down in celebrations involving persons well-known to one another(weddings, baptisms, first communions, etc.). The celebrant will instruct families ahead of time that social distancing must be employed and adhered too. Outdoor baptism, on parish grounds, are permitted at this time.

ADORATION OF THE BLESSED SACRAMENT: When it can be safely celebrated we will have Adoration after Mass for a limited period of time. People would remain in the seat they occupied for Mass, use masks, and maintain social distancing protocols. Adoration will not exceed one hour (and may not exceed two hours), unless staff is on hand to sanitize seating areas/any areas affected as congregants enter/exit the Church. Use of masks and social distancing will be employed. Adoration will not take place in a small confined space. I am requesting permission to have Adoration on Fridays for 1 hour after morning Mass. This will accommodate our vast retired population. Additionally, I am requesting permission to have another 1 hour of Adoration on Friday evenings to accommodate the working parishioners. The deacons and/or myself will

be present the whole time and monitor/clean/sanitize as needed. I ran this by our Bishop first and he said it would be okay as we comply with/follow the above guidelines.

CONFIRMATION: Pastors will continue to have delegation from the Bishop to officiate the Sacrament of Confirmation. Sunday Mass protocols will be followed. We will use individual cotton balls for anointing. No hand shake will be used but instead we will use a verbal wish for peace and a slight bow will be the substitute gestures.

QUINCEANERAS: Sunday Mass protocols will be followed. Gatherings before/after the celebration at the entrance of the Church/on Church grounds will be aggressively discouraged. At this time parish facilities will not be rented for celebrations. The guidelines listed above for mariachi bands applies.

PARISH MEETINGS: Ordinarily, we will hold meetings through technology. By exception, our meetings may resume in person but only when all participants are outside the "at risk" category guidelines of the CDC and the participants freely agree to participate. Others will be provided the opportunity to participate through the use of technology. All in-person meetings will use masks and adhere to follow social distancing protocols. Our meeting rooms will be cleaned/disinfected after use and between meetings. If we are unable to accomplish any of the guidelines we will resort to using technology for our meetings.

FIESTAS/SOCIAL GATHERINGS: These will not be allowed during this phase. There is a strong potential for social distancing/ protocols to collapse on these occasions.

FOOD PREPARATION/COOKING: Our parish will not be doing anything food related during this phase.

FUND RAISING/RAFFLES: These will need to be assessed on a case –by-case basis. Critical to this issue will be the extent to which safety protocols can be applied. Fund raising efforts involving food will probably not be permitted in this phase. Consultation/clearance with the county health department is mandatory before approaching the Diocese.
